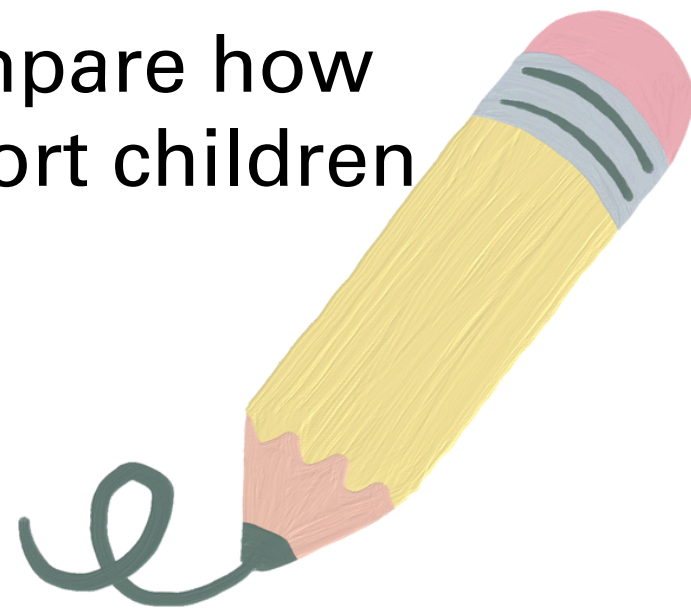


Children's Rights

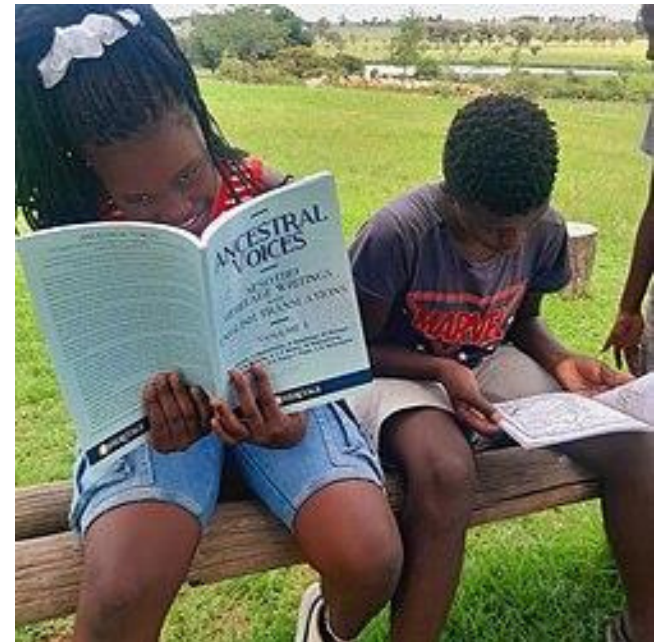

- Be safe
- Be heard

Children in Wales and Lesotho both have rights.



Key Words

Safe – feeling protected

Fair – everyone gets what they need

Listening – hearing people's ideas

Care – helping people feel supported

Fair does not always mean the same

Sometimes people need different support.

Example:

One child may need extra help to join a game.

Fair means everyone can take part.

Two different places.

But many shared values:

- Community
- Culture
- Belonging
- Hope

What Is Fair?

Is fair always the same as equal?

Fair means:
Everyone gets what they need,
not always the same thing.

Example:
If someone is unwell, they may
need extra help.



Children's Rights in Wales

In Wales, laws and services help protect children's rights.

For example:

- Schools help children learn
- Healthcare helps children stay healthy
- Children should be listened to in decisions that affect them

Children's Rights in Lesotho

In Lesotho:

- Education is compulsory in primary school
- Families and communities support children
- Some families face challenges like poverty or illness

Communities often work together to help children.

Question:

How can communities support children?



Helping: Two Different Ways

People around the world try to help each other in different ways.

Two common ways are:

Charity

Giving help to someone.

Solidarity

Working with people as equals to solve problems together.

Making communities fair

Sometimes people face barriers.

Communities work to:

- remove barriers
- listen to people
- include everyone



Everyone should be included

Sometimes people face barriers.



Communities work to make sure everyone can take part, including people with disabilities.



This might mean:

- making buildings easier to access
- listening to people's needs
- supporting people to make their own choices

Fair opportunities

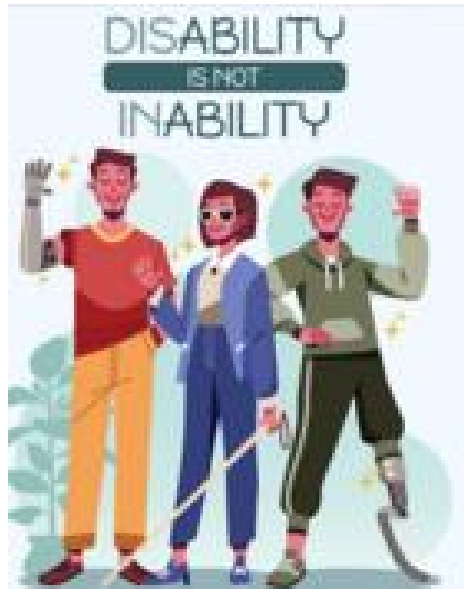
In many places people are working to make sure:

- Women and men are treated fairly
- Girls have the same opportunities as boys
- Everyone can learn, work, and lead

Communities continue
working to improve fairness.

The Welsh Government launched the Disabled People's Rights Plan for Wales 2025, which aims to advance the rights and opportunities of disabled people in Wales, remove barriers and challenge the prejudice and discrimination they face.

Human rights in Wales date back to 945 when the laws of Hywel Dda were published.

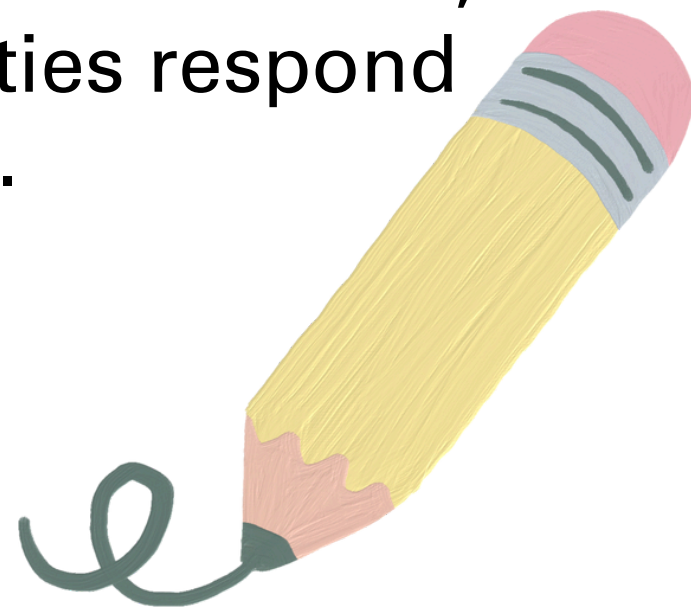


Band Aid and Health

Band Aid and Health

In the 1980s, musicians in the UK made a song to raise money for famine relief. It raised millions of pounds. Later, some people asked an important question:



Were African voices included in decisions about how help was given?

Health and Fairness

In Wales:

- The NHS was created so people could get care even if they had no money

In Lesotho:

- HIV has affected many families
- National programmes support prevention and treatment

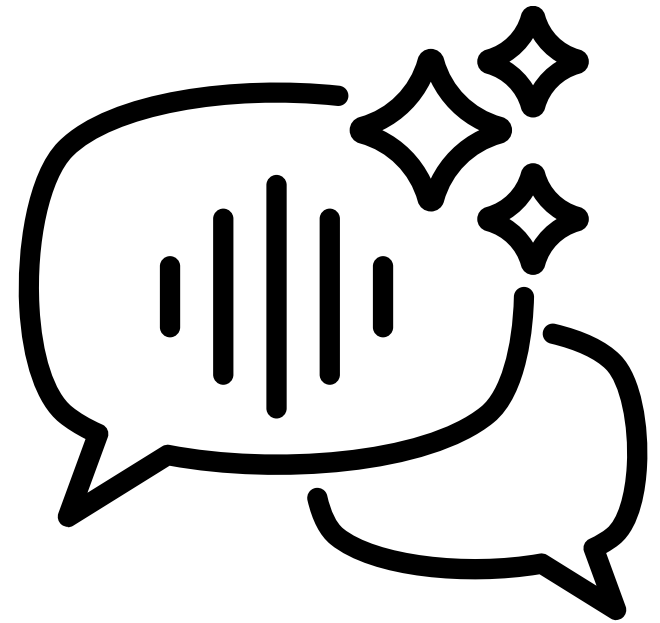

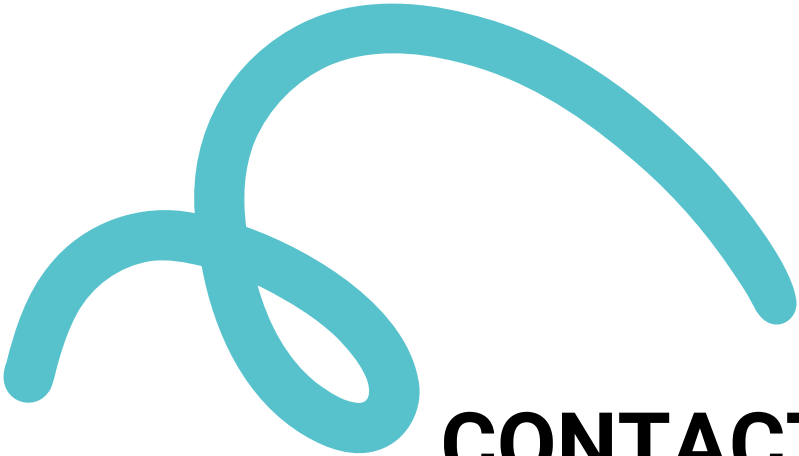

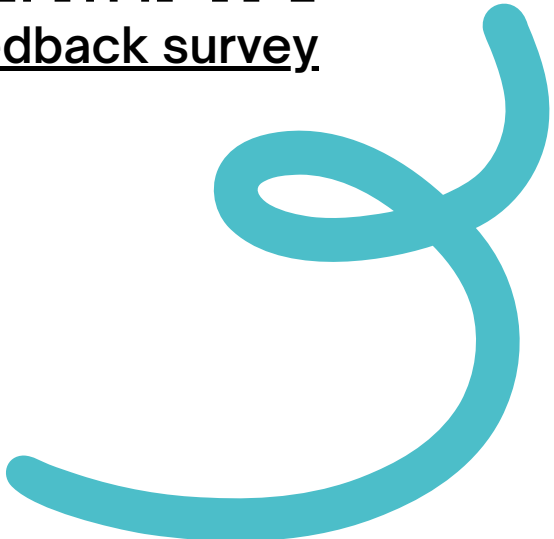
